The 2015 Global Forum on Migration and Development (GFMD) Summit held in Istanbul, Turkey endorsed a GFMD Business Mechanism as a pilot initiative to be implemented under the Chairmanship of the Government of Bangladesh. The summit concluded that business is concerned by migration and highlighted why there is a business case for engaging on migration policy. Governments and the private sector have a shared responsibility to identify migration policy solutions. In order to strengthen the added-value of the GFMD for sound migration policy, the GFMD Business Mechanism will serve as an avenue for regular public private sector interaction on migration policy.

Against this background, the business mechanism awareness meeting aims to discuss the state of play, as well as challenges in finding the interface between governments and business. Government experts, company practitioners and business federation representatives will discuss a number of issues that affect the mobility of skills in preparation for this year Business thematic meeting in New York and the GFMD Summit in Dhaka.

He was a member of the World Economic Forum and currently is a member of the CCCE in Canada, the Manitoba Business Council, YPO and is a Director of the Pearson Peacekeeping Center. He has a MBA from Harvard University and honorary degrees from the University of Manitoba and Cape Breton University. He was named an Officer of the Order of Canada in 2004 and awarded the Order of Manitoba in 2011.



François Fouinat, Senior Adviser to the Special Representative of the UN Secretary-General for Migration and Development

Since January 2006, he is a Senior Adviser to Peter Sutherland, Special Representative of the UN Secretary-General for Migration and Development. He played a central role in the conception and establishment of the Global Forum on Migration and Development (GFMD), the first global governmental process that deals with migration and its links with development, with a view to promote dialogue and cooperation.

Since 2001, he has been associated in various capacities to the work of the Commission on Human Security (CHS), first as Executive Director, then as Special Adviser and now as member of the Advisory Board on Human Security (ABHS), in New York. He previously performed a number of important functions in the UN humanitarian sector (UNHCR) in Africa, Latin America and Europe. After serving as Chef de Cabinet of the UN High Commissioner for Refugees Sadako Ogata, he was Director of the Asia Pacific region. Mr. Fouinat graduated from the Paris Faculty of Law and received a post-graduate diploma from the Institut des Hautes Etudes de l'Amérique latine, also in Paris.
